**Who Is a Florida Resident?**

For the purpose of determining eligibility for state financial assistance programs, a Florida resident is a person who has established and maintained legal residence in Florida for at least twelve months. Residence in Florida must be for the purpose of establishing a permanent home and not merely incidental to enrollment at an institution of higher education. Students who meet the federal definition of a dependent student are presumed to be legal residents of the same state as their parents.
